


RRC continues to advocate for protection of the Rainbow River and its environment.

Withlacoochee State Trail

Construction has finally started on the trail which will bridge the Withlacoochee River. This section of the trail will run from a trail head at the Dunnellon Little League Complex, west along the southern edge of the Blue Run Park, south along the old railroad right-of-way, across a new bridge spanning the river, and south to a trail head on CR 39 in Citrus County. This three mile section of the trail, including the bridge, is expected to be completed in about six months.



River Conditions

The final TMDL report for the Rainbow Springs and upper Rainbow River was produced in January and is posted on our website in the Education Section. As expected, the target level for nitrates is .35 mg/l which will require an 82% reduction in present nitrate levels. Recently, Marion County signed an agreement with FDEP to begin a BMAP (Basin Management Action Plan) for the Rainbow to identify major sources of the nitrate pollution and seek ways to meet the TMDL goal. The BMAP effort will be facilitated by Dr. Evan (Shane) Williams of the Marion County Storm Water Division. Stakeholders will be welcome to participate and RRC will pass along meeting announcements.

River Protection Ordinance Repealed

On April 8th the Dunnellon City Council voted to repeal Ordinance 2008-01 River Corridor Protection Ordinance. This repeal was driven by the special interests of

Councilman Dennis Evans who persistently misrepresented the content and purpose of the ordinance. Without this ordinance there are no upland restrictions on land use within the jurisdictional limits of Dunnellon that would protect the Rainbow and Withlacoochee Rivers and associated wetlands. Elimination of this ordinance removes water body protection requirements of building setbacks, vegetated buffers, and wildlife habitat preservation. Voting for repeal were Evans, Lynne McAndrew, and Eric Collop. Voting against the repeal were Mayor Nathan Whitt and Penny Fleeger.
