## **Springs Rally**

The Rainbow River and the ecosystems that it supports are dependent upon the quality of water entering at Rainbow Springs. This in turn is dependent upon the human activities that impact the 700 square mile spring shed that feeds these springs. Marion County has recently passed a Springs Protection Ordinance that will offer some restriction on harmful activities locally but we need statewide legislation to protect all of the springs in Florida. On February 16<sup>th</sup> there will be a statewide Springs Rally in Tallahassee in an attempt to influence our legislators to pass a springs protection bill this year. RRC is one of the sponsors of this rally and needs many volunteers to appear at the rally. Transportation will be arranged for the trip.

## **Blue Run of Dunnellon Park**

Plans for renovation of the CR 484 parking lot to alleviate storm water runoff into the Rainbow River are complete and are undergoing permit review. The project has been delayed but, hopefully, it will be completed before summer is here. Plans are nearing completion for an improved water access at the park. Further improvements, such as bathroom and picnic facilities, have been delayed because of the lack of Florida Forever funding. ## Threats to the River

We continue to be concerned with threats to the health of the Rainbow River. These include excessive levels of nitrates emanating from the springs and the loss of vegetation due to careless recreational uses of the river. We are also concerned with the Minimum Flows and Levels study proposed this year by SWFWMD. We know that it is foolhardy to think that we can extract water from the Rainbow and Withlacoochee Rivers to ship

southward and still have viable water ecosystems. Too little emphasis has been placed on statewide water conservation. Rainbow River Conservation has received a grant from SWFWMD to develop printed and video material to educate the public in protecting Rainbow River vegetation through proper visitor recreational methods.

### **Recent Events**

Burt Eno spoke at the Marion County Legislative Delegation meeting in November and at the Florida Senate Inland Waters Committee in December advocating for statewide springs protection and funding for Florida Forever. The RRC Education Committee continues to participate in the Rainbow Springs State Park environmental education program for high school students. This committee could use more members to achieve additional goals. If you can volunteer call Terry Blaes at 352-465-6492. RRC members serviced the wood duck boxes on the Rainbow River in November and found that 48 of the 49 boxes had nests in them.

#### Tasks For 2010

The coming year will prove to be eventful with important tasks to be accomplished. We must continue to advocate for funding of the Florida Forever program in order to protect sensitive lands from over-development, we must advocate for State legislated aquifer and springs protection to insure the quantity and quality of our drinking water and the health of our rivers, and we must support water conservation and oppose water transfers from our water bodies to South Florida. We must also continue to improve the Blue Run of Dunnellon Park and address the impacts of recreation on the Rainbow River.
